Once I get a student in 8th grade that struggles to read and do the math, they are several grade levels behind. Moving them just a grade level in a year is progress, but they are still behind. Parents/guardians and students must take greater responsibility for their learning. The culture surrounding schools and education must also change. The value and opportunity that education can make are just not valued enough How to change culture? That starts on the local level. Great leaders and teachers that are passionate, and families investing and promoting the value of education will certainly help improve outcomes. Highlighting successes and sharing what works will also be key to improving outcomes. In addition to education, an emphasis on greater mental health care for students must be addressed.

What ideas do you have for incorporating a focus on STEM education in our public schools and how could industry engage to support increased workforce learning models in middle and high schools, as well as career and technical education centers (vo-tech)?

Schools are offering more STEM education classes. Each county should have a career and technical center. Expanding vo-tech classes and allowing more students to be able to take field trips to learn about specific industries, allowing opportunities for students to shadow different careers where they see what that career looks like. Industry leaders visiting schools. I saw Creators Wanted to not just visit cities, but rural areas too. Last year some of the high school students visited a real construction job and learned about the bridge building process. Industry could foster those opportunities by helping students go on those field trips by sponsoring and working with schools.

Again, there are organizations that are engaging and supporting students. In my school, we have Career Technical Education and all 8th students are exposed to the sixteen career clusters. Guest speakers and hands-on activities are a major part of that class which helps students explore career options. Career fairs with representatives from different industries would help promote and inform students about the opportunities and how to land a career in the desired field.

Policies have to be examined to maintain economic and environmental issues. I would look to support policies that fit our current environment, promote innovation and new technologies, and eliminate duplicate regulations.
