Describe your overall philosophy toward the role of state government as it relates to business and industry.

The drug epidemic is a generational and significant problem in this state and it must be addressed immediately. Dealing with these issues would promote economic development in this state.

Fund early intervention programs and crack down on the pharmaceutical industry when their products harm the residents of our state.
