I also place emphasis on making sure there is a quality, well-trained workforce.

I have worked with the Kanawha County Recycling Center to help its ability to succeed by writing grants and administering grant funds; I have worked closely with the Kanawha County RDA and WV American Water to assist in getting new water lines run to serve several communities with no water in Kanawha County. I have worked with developers to insure new proposed subdivisions are designed and installed properly. I have worked with cell tower companies in getting cell towers in underserved areas of Kanawha County.

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

#### Q10

We need to enforce our drug laws and adopt tough on crime legislation to stop drug trafficking. I also oppose recreational marijuana since it is a gateway drug. We need to offer assistance to drug users to help them overcome their addiction.

#### Q11

How would you address these issues to recruit and retain companies and employees for whom this is a priority?

I would work to supply a well-trained reliable workforce with low-cost reliable energy and an environment that is business-friendly and pro-family. I am not interested in favoring companies with either conservative corporate values or liberal corporate values.

BridgeValley is an excellent resource to get potential manufacturing employees the basic job skills required. The instructors tailor course offerings to meet the needs of companies like Dow and Toyota. We also need to make sure our public education system is doing a thorough job of getting students good reading, writing math, and science skills, and a good knowledge of civics and social studies.

I would encourage parents and students to focus on academic achievement and the importance of education. We also should support vouchers to allow low-income families the opportunity to send their children to private or home schools, much like wealthy parents.
