West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

West Virginia still has opportunity to be more competitive on the national stage to foster a friendly business environment. More work is needed on tax policy (eliminate equipment+inventory tax and PIT), regulatory policy, and more investments in site development must be made going forward.

Population loss is of concern as we lost a congressional seat and businesses are looking to fill their good jobs with workers. So many of our problems are symbiotic in nature and moving forward on good tax policy (eliminating PIT) as well as infrastrucuture and site development can help with many problems, including population loss.

Education is a passion of mine and West Virginia has gained ground on the policy side. Results always lag policy decisions but I belive WV is on the right track by diversifying our education system and proving more competition and opportunity for our students and teachers.

Do you support the passage of Amendment One on the November 2022 General Election ballot? The measure provides the legislature with the authority to repeal or phase out tangible personal property in the future, this includes tax on personal vehicles, small business inventory, and tax on manufacturing inventory, machinery, and equipment.

Yes, 100%! As someone who works in economic development I can't stress enough the importance of passing this amendment and eliminating the equipment and inventory tax.

Use of and addiction to opioids in West Virginia and our region have reached crisis levels. This is a problem being recognized not only at the state level, but at the federal level. What ideas do you have to help stop this devastating trend in our state?

As previously mentioned a lot of our problems (and solutions) are symbiotic in nature. If we start to address the business climate, more companies will start and locate here which leads to more jobs. More jobs provides more opportunities and solves a lot of problems and gives people hope.

I do believe we will have to develop more solutions on the mental health side of healthcare, as drug abuse (including opioids) and mental health are heavily correlated. We should work toward giving people hope and opportunity, and we should also attack the problem more from a health angle vs. a criminal justice angle.

Racial justice and equity, LGBTQ rights and gender equity are important factors for many current West Virginia employers, companies that consider moving to our State, and employees who may consider relocating to West Virginia. How would you address these issues to recruit and retain companies and employees for whom this is a priority?

I believe we must continue to foster an environment that is fair for all and ensure EQUALITY for all looking to make West Virginia a better place.

Q12

What are your specific ideas for addressing workforce skills gaps in industry? Specifically, with the growth of manufacturing jobs in the state and need for diverse and skilled labor, what are your ideas to prepare the state's current and future workforce for manufacturing jobs.

More collaboration is needed to foster relationships between our higher education institutions (colleges as well as trade schools) to address gaps and needs. I have always been surprised by the employer side stating they have these needs, and then the higher ed institutions saying they can and do provide these skills and training. There is a relationship gap that exists at times. In Mercer County we have tried to foster these relationships so that businesses are connected to these institutions of higher learning and can build worker pipelines, tailer their curricula, and begin to fill these needs.

What are your ideas for improving outcomes in the state's K-12 public education system?

We must continue to support the Hope Scholarship program and diversify our educational system. Voting for and approving Amendment 2 on the ballot in November (enacting legislative rulemaking oversight) is also a big step toward improving our system. Continuing to utilize all tools we have (including pay raises) for school personnel to attract and retain our talent.

What ideas do you have for incorporating a focus on STEM education in our public schools and how could industry engage to support increased workforce learning models in middle and high schools, as well as career and technical education centers (vo-tech)?

My hope is to see the growth of charter schools in the state that could put an emphasis on STEM. I believe a deep-dive into curricula is also necessary to determine if what is currently being taught is relevant to 21st Century needs.

Please describe policies that you believe may be helpful in balancing state regulations and environmental rules while maintaining a competitive atmosphere for industrial job growth and investment?

We must always maintain clean air, clean water, and smart regulation when it comes to business and the environment. I believe West Virginia does a great job at our DEP in maintaining this balance. The real threat comes from federal overreach such as WOTUS and other crazy ideas that threaten industry.

What do you think West Virginia could do to promote energy diversity including the growth of renewable energy sources in the state?

We must always maintain a level playing field when it comes to energy. That simply means not picking winners and losers and allowing the market to develop. I was proud to cast a vote in the 2022 session to repeal the ban on nuclear energy in the state and I hope that will become a bigger industry in the future.
