We have established a land re-use agency to achieve these goals.

West Virginia is facing many challenges. What do you consider to be the most important and critical challenge that threatens our state and what is your plan to alleviate this threat?

We must continue to take steps such as reforming our tax code, elimination of the business and inventory tax, and work with investors to attract business and industries that will provide economic opportunities that are essential to stop our population decline.

Lastly, and thinking more long-term we need a serious analysis of the fifty-five county board system. In a sate with declining population we are wasting lots of money maintaining an vast bureaucracy that could be consolidated to provide better, more efficient educational services.
